Accommodation boasts generous living areas comprising ground floor entrance porch, hallway, lounge, two double bedrooms, family bathroom, kitchen/diner and utility/rear porch. First floor comprises two further bedrooms and W/C.

Heating in the property is by way of oil central heating and multi-fuel stove in the lounge, and windows are uPVC throughout.

Externally there is low maintenance garden ground to the front and rear of the property.

Separate Croft Tenancy with 4m x 12m Polycrub at 10 Carishader is also available for purchase by separate negotiation, extending to approximately 0.684 hectares (1.69 acres) ideal for many agricultural uses and offering a versatile and sustainable opportunity to extend the growing season and protect crops.










Floor Plan
